DANGER - ULTRAVIOLET RADIATION

State/Federal Policies:

- Follow operator, tanning unit, eyewear and safety instructions.
- Avoid too frequent or lengthy exposure or overexposure; this causes burns. As with natural sunlight, exposure to a sunlamp may cause eye and skin injury, sunburn and allergic reactions. Repeated overexposure may cause chronic damage characterized by wrinkling, dryness and premature aging of the skin and skin cancer. Ultraviolet radiation from sunlamps enhances the effects of the sun. Do not sunbathe before or after exposure to ultraviolet radiation.
- Wear protective eyewear that complies with U.S. Federal Regulation 21 CFR 1040.20. FAILURE TO USE PROTECTIVE EYEWEAR MAY RESULT IN SEVERE BURNS OR LONG-TERM INJURY TO THE EYES.
- Abnormal or increased skin sensitivity or burning may be caused by certain foods, medications (including, but not limited to tranquilizers, diuretics, antibiotics, high blood pressure medication, birth control pills, and skin creams), cosmetics or toiletries. Consult a physician or pharmacist before using a sunlamp if you are using prescription or non-prescription medications, have a history of skin problems, or believe yourself especially sensitive to sunlight. Pregnant women and women on birth control pills who use a tanning device may develop discolored skin.
- Any person with skin that burns easily should avoid an ultraviolet tanning device.
- Any person with a family history or past medical history of skin cancer should avoid an ultraviolet tanning device.

Salon Policies:

- If you are or become pregnant, do not use any tanning units and inform the salon staff.
- Ultimate Tan reserves the right to refuse service to anyone for any reason, and we do not allow clients to split, transfer, share, or extend memberships and packages.
- Children under 12 years old cannot be left unattended. Only one person per tanning room.
- I understand and agree to comply with all the Magic Tan instructions. I am using these services at my own risk. I acknowledge that the results of spray tanning vary and that no guarantees of specific results are offered or implied. I hereby relieve Ultimate Tan, as well as the staff from any liability involved in the use of the spray system.
- Ultimate Tan does not allow the following products to be used while tanning: outdoor tanning lotion, Maui Babe, iodine, sprays, or any products with mineral oil, including SPF's with mineral oil.
